

# Reagan seeks 12.5% increase in foreign aid

WASHINGTON — Despite the push to cut the federal budget deficit, the Reagan administration has asked Congress to increase foreign aid by 12.5 percent over the current fiscal year, to a total of \$16.3 billion.

The aid request for fiscal 1987, which begins next Oct. 1, was sent to Capitol Hill this week. A copy was obtained from congressional sources.

In it, the administration calls for a doubling of military assistance to the Philippines and Guatemala, and modest increases in funds for other Central American countries, like El Salvador and Honduras, which are seen by Washington as key obstacles to the spread of Soviet influence in the region.

The military aid to the Philippines would restore cuts made by Congress last year and would conform to an agreement signed in

1983 with President Ferdinand Marcos that committed the administration to seek \$900 million over five years in return for the use of the two major military bases.

In the Middle East, the large aid packages for Israel and Egypt would remain about the same as this year, with a total of \$2.3 billion requested for Egypt and \$3 billion for Israel. This year's aid to Israel was augmented by a supplemental authorization, bringing the total to \$3.75 billion. Israel thus remains the world's largest recipient of U.S. assistance, followed by Egypt, Turkey, Pakistan and Greece.

The requests are expected to face some cutting by Congress, whose budget process is dictated by the Gramm-Rudman Act. The new measure requires a balanced budget by fiscal 1991 and forces staged reductions in the deficit.

Mark Helmke, an aide to Sen. Richard

Lugar, R-Ind., chairman of the Senate Foreign Relations Committee, said although Lugar had not seen the aid requests, he was sure they would be given close scrutiny.

Helmke said Congress passed a two-year authorization last year that would hold the 1987 aid program to the same total as in 1986, namely \$14.5 billion. The purpose, he said, was to introduce some continuity and predictability into foreign aid.

He cited reports that much of the aid to famine victims in Ethiopia had not reached the people in need. The administration has requested \$3.4 billion in food for Ethiopia, about the same as Congress authorized for this year.

Helmke said the Foreign Relations Committee would meet in closed session with administration officials today to discuss the package.

The case of the Philippines was dictated by past obligations rather than by the disaffection of the administration with Marcos.

Under the 1983 agreement involving Clark Air Base and Subic Bay Naval Base, the \$900 million the administration pledged to seek over five years was to be divided between economic and military aid.

Last year's request of \$102.2 million in military aid was pared down by Congress to \$54.7 million, with some of the difference shifted to economic aid, which was authorized at \$184.2 million. This year's military request is \$102.7 million, just above the level requested last year, but nearly twice the amount authorized. The administration has asked for \$125.7 million in economic aid for next year.

The military request is especially likely to run into opposition, congressional sources said, in the absence of any clear evidence

that steps have been taken to reduce what officials see as nepotism and corruption in the Philippine military.

Congress also cut the military aid request for Guatemala last year from \$10.3 million to \$5.07 million. Now the administration has asked for \$10.5 million, possibly in the hope that the recent Guatemalan election of a civilian president, representing a move toward democracy, will improve the country's image. Economic aid to Guatemala would also rise under the request, from \$99.3 million this year to \$133.7 million.

El Salvador, which is fighting a leftist insurgency, would receive \$378 million in economic and \$136 million in military aid, up 18 percent from the total this year. Honduras would get \$158.8 million in economic and \$88.8 million in military aid, up 37 percent from this year's total.

## Black students end boycott of South African schools

JOHANNESBURG, South Africa (AP) — Black students ended two years of school boycotts Tuesday and streamed back to classes to prepare for the new academic year on the strength of a pact parents reached with the white-led government.

Attendance was heavy as schools reopened in urban centers including Johannesburg, Pretoria, Cape Town and Port Elizabeth, where boycotts cut attendance for much of 1984 and 1985.

On some days in recent months, more than 200,000 black students boycotted classes out of 1.7 million enrolled in urban areas. The boycotts have been a central factor in 17 months of racial unrest that led to the deaths of more than 1,000 people, most of them blacks.

Outside a school in Johannesburg's huge black township of Soweto, police used tear gas to break up groups of

chanting students, residents said. But there were no other reports of trouble, and the fragile accord appeared to have opened the door to normalizing the long-troubled black schools.

Police reported the stabbing deaths of four black men in a fight between rival gangs at a squatter camp outside Cape Town. Police headquarters in Pretoria also acknowledged riot patrols shot dead a 15-year-old girl and a 35-year-old man Monday in Kagiso, west of Johannesburg.

The girl was slain after police broke up a rally to debate whether to return to school, one of several such meetings banned by authorities. The Kagiso youths decided to go to school Tuesday, but a black newspaper noted the accord could be threatened by such incidents.

Boycotts over black demands for equal education with white children started in early 1984 as part of the

protest against apartheid, the system of legal racial segregation under which 5 million whites deny the vote and other rights to 24 million blacks.

A breakthrough came in late December, when education officials negotiated with the National Parents' Crisis Committee, a group with widespread backing from activist youths.

Demands included the withdrawal of soldiers from riot duty in the townships, an end to the state of emergency and the release of detained leaders as well as educational grievances.

Education officials, acknowledging thousands of youths had boycotted end-of-year exams in November, also agreed to set up a second set of exams in February and March for boycotters and to begin the 1986 academic year in April.

## Activist Means hurt in Nicaragua

SAN JOSE, Costa Rica (AP) — American Indian activist Russell Means was slightly wounded while traveling with Indian rebels inside Nicaragua, a spokesman for the Murrasata rebel group said Tuesday.

Delano Martin, executive secretary of the Nicaraguan Indian guerrilla organization, said the Sandinista air force bombed a rebel-held village inside Nicaragua on Saturday while Means and other Indian activists were there.

Martin said four civilians were killed and 15 wounded in the aerial bombardment of Laya-Siska on the isolated Caribbean coast of Nicaragua. He said Means suffered slight arm and leg wounds, and remained in Nicaragua.

Means had told reporters here he would visit the Nicaraguan coastal region to assess conditions there.

Nicaraguan Indians have been fighting the leftist Sandinista government for four years, resisting the application of government policies in the remote region and seeking autonomy.

## UW Business School to lose 4 professors

The UW-Madison School of Business will lose four of 12 professors from its Finance Department this spring, including department Chairman Charles Kroncke.

Kroncke, along with James Pappas and Robert Haugen, will leave to take more lucrative posts at universities in other states. The fourth professor, Donald Knight, plans to retire.

"We're actively recruiting to fill the positions now," said Kroncke, who also is an associate dean of the business school. "I don't have any doubt but that we'll fill them. Between the city and the university it's a piece of cake."

"The school has identified a number of bright prospects," said Pappas, who directs the school's new Center for Business Venture Development, a program that aims to help entrepreneurs find capital for their business ventures. "The UW salary structure is really competitive at the entry level."

However, he added, "There's no question that we have trouble retaining senior faculty because of market competition."

Pappas also directs the school's applied security analysis and investment management program, a two-semester seminar that allows students to invest a total of \$250,000.

Kroncke, who will leave to become dean of the College of Business at Auburn University, Auburn, Ala., said the faculty turnover probably will not harm the UW business school's teaching or research reputa-

tion. "I've sensed some students are concerned," said Pappas, who will leave to take an endowed professorship at the University of South Florida, Tampa. But he said, "this is not a disaster. This provides the school with an opportunity to recruit some new people."

Kroncke and Pappas joined the UW faculty in 1968 along with Robert Haugen, who is on leave this semester at the University of Illinois, Champaign-Urbana.

Knight, who plans to retire at the end of this semester, joined the UW-Madison School of Business faculty in 1945 and has been chairman of the finance department and director of the Bureau of Business Research.
